



This second edition consists largely of new material that charts how recent political developments have changed the debate surrounding Britain's membership of the EU. Following the 2015 general election and with an upcoming referendum on Brexit, Roger Liddle assesses the impact of a series of miscalculated gambles by David Cameron and his forebears that leaves Britain teetering on the edge of an exit from the European Union.



The risk for the Labour party is further electoral defeat and then inevitably, permanent irrelevance. As of today, there are few signs that the party grasps why it lost and, in particular, why swing voters in marginal seats were not prepared to vote Labour. This book examines why Labour so overwhelmingly lost the trust of voters, and crucially how the party under a new leader can win them back by 2020 - charting Labour's path to power.

This book is about the turbulent political scene unfolding in Britain and across western Europe. It focuses on why large swathes of voters feel that politics does not work and how this fuels support for insurgent parties and actors. Drawing on original survey data in the UK, interviews and international case studies, this book shows that people are concerned with the process of politics, not merely its performance. They have a genuine desire for greater political participation in the decision-making process.

Setting out a range of democratic innovations to reconnect people with politics, this book contends that populism is a warning signal to parties and governments to revisit their approaches to governance and representation.


